Dear Exhibitor

Thank you for entering your exhibit in our show. The emphasis will be a working show. We would like to demonstrate the engines working as they would have, so if you have any machinery or equipment which can be driven by your engine please let your steward know and bring it along.

To ensure everything runs smoothly, we kindly ask if you can please abide by these few rules:

CONDITIONS OF ENTRY

1. No entry to show site before 10am Friday 22 June, leave by 11am Monday 25 June.
2. All exhibits to be in position by 9.30am on the show days and to remain on the rally field until 5.00pm.
3. All passes to be clearly displayed. NO PASS - NO ENTRY
4. All exhibits, transport vehicles, etc. are brought onto the site at owner's risk and are to be parked in designated areas.
5. Upon arrival and for the duration of the show, exhibitors will be under the instruction of the section stewards and officials appointed by MSRVS.
6. A maximum speed limit of 5 MPH shall apply to all vehicles on site and must be kept to a minimum.
7. Your engine must be insured for boiler explosion, third party and public liability risks including use on a rally field, with a minimum indemnity of £2,000,000 any one occurrence. Insurance must be available if requested by event organisers or stewards.
8. Please provide information relating to any demonstrations that you wish to carry out during the period of the show, if applicable. Other safety information may be requested by the MSRVS.
9. All drivers of vehicles must hold a current driving licence or authority appropriate to that vehicle.
10. Please keep children and pets under close supervision at all times.
11. All B-B-Qs to be kept clear of the ground
12. Dispose of fires and ash carefully as advised by section steward.
13. Keep grounds clear of litter at all times.
